Sub: Clarification regarding relaxation for travel by Air to visit NER- CCS (LTC) Rules, 1988.

Sir,

DOT Circular No. 209 dated 23.05.2008 forwarding the DOP&T O.M. No. 31011/4/2007-Estt(A) dated 02.05.2008 was endorsed by BSNL vide this office circular no. 93 dated 27.5.2008 to all field units wherein BSNL employees are allowed to travel by air to North Eastern Region on LTC. Subsequently some field units have raised certain query / doubts for clarifications which has been examined and clarified as under.
